New IRS Requirements for PTINs

The IRS is moving ahead with new requirements for Personal Tax Identification Numbers. The new regulations will require all paid tax return preparers, including CPAs, attorneys and enrolled agents, to apply for a PTIN (***even if they already have one***) prior to preparing any federal tax returns in 2011. The IRS has indicated that all paid preparers should apply for, or renew, their PTINs before January 1, 2011.
